Official Rules**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.**

- 1. OVERVIEW:** Slotoawards Contest (the "**Contest**") consists of a contest where eligible Entrants can enter and whereby five (5) Entrants will be named winners.
- 2. ELIGIBILITY:** Contest is open worldwide to individuals who are 21 years of age or older ("Entrant(s)"). Employees and the immediate families of Playtika LTD ("Sponsor"), Playtika LDA ("Administrator"), and each of their respective employees, representatives, franchisees, parents, retailers, distributors, subsidiaries, affiliates, suppliers, advertising agencies, and persons living in the same household as such employees are not eligible to participate in the Contest. Contest is subject to all applicable federal, state, provincial, local laws and regulations and is void where prohibited by law. Sponsor reserves the right to verify the eligibility and all facts at any time, and Entrants agree to cooperate in any verification process/request.
- 3. CONTEST PERIOD:** The Contest begins at approximately 12:01:01 am EST and ends at approximately 11:59:59 pm EST each day starting on September 14, 2023 and ending on September 22, 2023 ("Contest Period").
- 4. HOW TO ENTER:** During the Contest Period, visit <http://www.awards.slotomania.com> and provide your account ID ("Account"), and all other required information). If you do not have an Account, you can follow the on-screen instructions to create one for free. An Entry consists of your personal information and your ("Contest Submission") which shall include a statement of minimum 100 words written by you or a video of minimum of 30 seconds which is prepared only by you and tells us why you are a good fit for the category you are registering for. Incomplete Entries are void. Limit of one (1) Entry per person per category and/or email address per Contest Period. Each category requires a separate application.

Any attempt to enter more than once by any means, including, but not limited to, use of multiple identities, email addresses, accounts, or other means may result in disqualification from this and any other promotional offerings by Sponsor. Use of any macro, bot, script or other automated means to submit entries is prohibited. No responsibility is assumed for lost, late, damaged, misdirected, illegible, incomplete, incorrect entries or other Contest Submissions, all of which are void, or for errors due to computer malfunctions, software errors, transmission problems or interruptions in operations.

- 5. WINNER SELECTION / NOTIFICATION:** There will be five (5) winners selected.

Beginning on/about September 22, 2023, a review and judging of Contest Submissions shall occur as follows:

Step 1 – registration of details and submission of applications and story to one of the categories;

Step 2 - A selection panel will contact and review all applicants. Administrator and/or an agency on its behalf shall select 2-3 final nominees from each category listed. The judging criteria shall be:

30% Originality

40% Screen Presence of Vide and/or Writing Ability if written.

30% Enthusiasm for game

Finalists will be presented to the community.

Step 3 - Stories are shared with the community for voting to determine the finalists. Voting is based on the same criteria detailed above.

Step 4 - Panel members will contact winners to arrange an on- camera interview to record their story.

Entrants irrevocably agree to be bound by these Official Rules and by the decisions of the judges, which are final and binding in all respects.

6. **GRAND PRIZES:** five (5) available – Five (5) Winners will each receive a trip for two (2) to Tel Aviv Israel. Trip will include round-trip coach airfare from the major airport nearest the winner’s residence, four (4) consecutive nights hotel accommodations transportation, tours, etc. Winner must be available on the dates; no substitute dates or prize are available. If Winner is not available, the prize will be forfeited. Approximate Retail Value (“ARV”): USD 4000.

Conditions Applicable to All Prizes: Each potential winner will be notified using the contact information supplied at time of entry. No liability is assumed for any winner notification that is lost, intercepted or not received by a potential winner for any reason. Failure to respond to any winner notification within 48 hours may result in disqualification and selection of an alternate winner. Prize winners are solely responsible for all applicable federal, state and local taxes, and any other costs or expenses not specifically set forth herein. Each winner must: (a) have all ID and other documents necessary for travel, including but not limited to a valid passport, visa with 6 months validity from the day of the trip and vaccination requirements; (b) Be physically able to travel to Israel between December 3rd & December 8th; (c) Agree to be recorded and appear on camera during the tour & ceremony and to have the Sponsor use such recordings; (d) Agree to a camera crew visit before the event for an interview; and (e) Respond within 48 hours (about 2 days) to any nominee or winner notification. Winner will be required to sign a Liability/Publicity Release (where legal) prior to ticketing.

No responsibility is assumed for cancellation or postponement of any prize-related event or travel beyond Sponsor's control, including delays or cancellation of travel due to pandemic restrictions.

Sponsor may conduct a background check to confirm any potential winner's eligibility and compliance with these rules. By entering, you agree to cooperate reasonably with any such background check.
